## INDIVIDUAL MEMBERSHIPS

### PROFESSIONAL

For individuals employed in administrative, supervisory, leadership, educational, or support roles in Parks & Recreation.

### INTRODUCTORY

For first-time TRAPS members or recent graduates transitioning from Student membership.

### COMMERCIAL

For individuals or companies providing products and services to parks, recreation, and conservation agencies, allowing up to three (3) representatives to be registered under the membership.

### AFFILIATE
